Rental Information, Terms and Price List

The German - American Club of Albany is a social club dating back over 125 years dedicated to the past, present and future of German traditions, culture, and hospitality in New York's Capital District. Our Clubhouse rental facilities include a spacious and elegant banquet hall measuring 32' wide x 83' long with 12' high ceilings and can accommodate up to 150 people. The hall can be divided in half to hold smaller groups. The hall also features a large raised and lighted stage measuring 32' wide x 14' deep with two sets of front steps from the dance floor. The stage is perfect for bands or DJ's while your guests enjoy the dance floor. Internet Wi-Fi service is available in the Clubhouse.

The fully equipped bar and cocktail room measures 20' wide x 31' long and is an excellent choice for hosting your smaller events such as showers, birthdays and any other occasion up to 50 people.

Other clubhouse features include a bridal dressing room for the newlywed bride, a coatroom, mood lighting, bright master lighting when necessary, and ample on-premises parking.

During the summer, when not already reserved for our own summer picnics, the shaded Biergarten is available for rental. The last original German Biergarten remaining in the Capital District, our picnic area can easily accommodate over 400 people. And includes a grilling pavilion, bandstand, dance floor, bar area, and restroom facilities. Whether you are planning a wedding ceremony, family reunion, picnic, company outing, or a fundraiser our outdoor facility would be perfect for your warm-weather occasion.

As indicated above, a non-refundable deposit is required to guarantee your reservation. Until we have received your deposit and a signed agreement, your booking is not guaranteed. Fees do not include the use of the bar and bar refreshments. **Use of the hall/space is limited for a total of five hours.** For each additional hour – up to three (3) hours max, the hall is available for \$150.00 each hour, but needs to be approved by the Rental Chair/Monitor prior to the event. **\$50/\$100 (depending on the number of bartenders needed) per hour for each additional hour will be added to your bill as well.** The deposits are credited to your final bill.

Ninety (90%) of the total estimated bill shall be paid by cash, money order or Bank check and will be submitted with the final count no later than two weeks prior to the affair. There will be a 10% surcharge based on original contract count for any late payments. Bill must be paid in full at the end of the event by cash, money order or Bank check only. Please note Credit Card payments are not accepted.

For the purpose of Host (renter): an estimated attendance figure is to be provided at the time the event is scheduled. A final minimum guarantee of attendance must be provided 10 days prior to the event and once received may not be reduced.

BEVERAGE POLICY

1. As a licensee of the State of New York alcohol beverage control authority, the German-American Club of Albany strictly adheres to all laws and regulations pertaining to the service and sale of alcoholic beverages. No beverages of any kind will be permitted to be brought into our facility by the clients and/or guests.
2. We will require I.D. for those patrons who look under the age of 21.
3. No sales will be made to minors or intoxicated persons.
4. Management reserves the right to refuse service of alcoholic beverages to anyone appearing intoxicated, close the bar at its discretion and terminate any disruptive affair immediately.
5. Top level Open Bar does not include the service of shots and/or pitchers of beer.
6. If beverages are served (alcoholic or non-alcoholic) a \$50 bartender fee will be required. If an additional bartender is needed, dependent upon size of group, additional fees are applicable.

OUTSIDE VENDERS

1. All outside vendors must be set up completely, 1 hour prior to the event start time.
2. Florist, Bakeries, Decorations and D.J.'s must co-ordinate their set-up start time with the Banquet Chair staff if applicable.

3. Chair covers must be contracted through outside vendors.
4. D.J.'s /Band must adhere to the German-American Club of Albany, New York rules and regulations.

GENERAL CONDITIONS

Initial _____ Date _____

1. The German-American Club of Albany, New York maintains a smoke free environment. An outdoor smoking area is provided.
2. The German-American Club of Albany, New York neither accepts nor assumes any liability for theft of or any loss of personal property occurring either prior to, during, or after the event.
3. Entertainment must stop by 11:00 p.m.
4. No fog or smoke machines are allowed.
5. All table centerpieces and decorations must meet fire safety codes and regulations. All candles must be enclosed. No more than one center candle and four votive candles are allowed per table due to fire safety issues.
6. The German-American Club of Albany, New York does not allow anything to be affixed to the walls, ceiling, furniture, fixtures, furnishing or any other property. Failure to comply with the policy will result in an additional charge for the cost of repairs and/or replacement of damaged property. Removal of all client supplied decorations is the client's responsibility. This must be done on the day of the event prior to your departure.
7. Throwing or use of tinsel, rice, confetti, or glitter is not allowed in the building or outside (clean-up charge \$150.00).
8. Client is responsible and will provide adequate adult supervision for small children and will be held responsible for acceptable behavior of the children as it relates to the German-American Club of Albany property.
9. Beverages may **not** be brought onto the grounds or into the Clubhouse. Self-catering or outside catering is permitted. Use of the kitchen is available at **\$100.00** for 2 hours only! The kitchen clean-up must be done within the 2-hour time frame. All trash must be taken out by the client at the end of the event and placed in the appropriate container, located outside in the rear parking lot not placed on the ground.
10. If the German-American Club of Albany, New York is unable to perform its obligations under this agreement for an reason beyond its control, including but not limited to strikes, labor disputes, accident, government restrictions or regulations on commodities or supplies, acts of war or acts of god such as but not limited to storms, flooding, power outages, or inclement weather, such non-performance will be excused and the German-American Club of Albany, New York will not be liable for any consequential damages of any nature, and any monies or deposits will be returned in full.
11. All prices subject to change without notice.
12. Clean-up of the hall must be done during the time of your rental. The hall must be left as before your rental.
13. No beverages of any kind can be brought onto the premises. If your guests are found bringing in their own beverages, including alcohol, you will be notified your party has ended and no refund will be provided.
